Separate design required for each road based on site condition

- 4) Sri Cheriyan asked about carriage way width required? 3.75m or as per traffic
- 5) Sri Cheriyan asked about the specification to be followed (MoRTH or MoRD)?
  MoRTH / MoRD
- 6) Sri Cheriyan asked about minimum specification required?

7) Sri Balakrishna Pillai Asked whether 100% of construction cost will be paid after the completion of project.?

Payment as per RFP clause 3.4

- 8) Sri Cheriyan asked whether Survey details will be shared? Not applicable
- 9) Asked about works will be monitored or supervised? Three tier system
- 10) Bidder asked about ownership of the tendered works?
  Owner ship vests with Government/Local Body but the Road will be transferred to the contractor for works and only taken back after maintenance period
- 11) Bidder asked about how utilities, advertisement boards etc shifting is to be done. Procedure adding to above, how to remove ramps from households etc? Utilities will be removed by the contractor and the amount will be reimbursed
- 12) Bidder asked whether profile correction is to be proposed in these roads. Bidder pointed out that local issue may arise in slope correction? Minimal Profile correction needed as per site condition
- 13) Whether MLA's of the corresponding constituencies need to be intimated about the projects?
