## **ORDER**

Government, vide order read as 1<sup>st</sup> paper above, have issued Administrative Sanction of Rs. 26630.37 lakhs for the construction of 218km flood affected roads in Pathanamthitta, Idukki and Wayanad Districts in DBMT Mode. Vide order read as 3<sup>r d</sup> paper above, Government have accorded sanction to change the mode of implementation from DBMT/ DBOT mode to Item Rate Contract Mode, for reconstruction of flood damaged LSGD roads through RKI PMU, LSGD.

- 2. Since the PMU, RKI LSGD is engaged in preparing the DPR for 398km of roads, Project Director, vide letter read above, has requested to issue sanction to outsource the design and DPR preparation of 218km roads in Pathanamthitta, Idukki and Wayanad Districts, for an estimated amount of Rs. 1,60,50,000.
- 3. Government have considered the matter in detail and are pleased to accord administrative sanction for 'Consultancy services for design and DPR preparation of flood affected roads in Pathanamthitta, Idukki and Wayanad districts' for an amount of Rs. 1,60,50,000 (Rupees One Crore Sixty Lakhs and fifty Thousand only). The expenditure towards this preparatory work may be met from the funds already allotted to PMU-LSGD as per order
