#### **ORDER**

As per references cited as 4<sup>th</sup> & 5<sup>th</sup> above, Administrative Sanction was issued for the reconstruction of a total of 36 LSGD road works through the PMU LSGD at a total estimated cost of ₹ 80.25 crore.

- 2. Now, the LSGD, as per reference cited 6<sup>th</sup>, 7<sup>th</sup> & 8<sup>th</sup> above, informed that 9 works out of these 36 works were quoted above the approved estimate. As per the clarifications issued by the G.O. read 2<sup>nd</sup> above, the admissible contract amount is the least of: (i) Negotiated contract PAC of L1, (ii) Estimate amount based on current LMR, and (iii) Estimate amount based on current DSR plus 10% tolerance limit.
- **3.** The Project Director, PMU has reported that the excess amount quoted for all the 9 roads are within the acceptable limits as stipulated by the G.O. cited 2<sup>nd</sup> above, and that the Tender Committee has recommended the L1 in all the works, subject to approval from the Government. The details of the roads, quoted excess amounts, revised estimates etc. are attached at **Annexure** to this order. Further, the Project Director, PMU has reported that the additional amount of ₹2,01,39,702/- required for these roads shall be met from the available savings to

the tune of ₹4,52,93,828/- from other works sanctioned under the same Government Orders read 3<sup>rd</sup>, 4<sup>th</sup> & 5<sup>th</sup> above.

- **4.** The Government, after having considered the matter in detail, are pleased to approve the additional expenditure of ₹2,01,39,702/- (Rupees Two crore One lakh Thirty Nine thousand Seven hundred and two only) required for meeting the tender excess for the reconstruction of 9 LSGD roads to be implemented through the PMU-LSGD, as detailed in the Annexure. Sanction is also accorded to meet the additional expenditure in this regard from the savings accrued from other works sanctioned under G.Os read 3<sup>rd</sup>, 4<sup>th</sup> & 5<sup>th</sup> above.
- **5.** The expenditure will be debited to the budget provision under H/A 5475-00-115-94 Post flood Projects under Rebuild Kerala Initiative (P). The Government Orders cited 4<sup>th</sup> & 5<sup>th</sup> above, and the Annexure thereof, stand modified to this extent.
