ORDER

Out of the 87.113km of road included to be rebuilt in Wayanad district as part of Rebuild Kerala Initiative vide Government Order read as first above, KIIFB prepared Draft Project Report of 63.3km after conducting initial survey. The remaining road totalling to a length of 23.813km had to be surveyed by the Project Management Unit, RKI, LSGD. Expression of Interest was invited from consultants for Topographic Survey of the 23.813km of roads and work was awarded to the lowest quoted bidder Sri. Arun Babu, at the rate of Rs.8750/- per kilometre and 18% GST. The probable Amount of Contract (PAC) is Rs.2,45,870/-.

The Project Director, PMU vide letter read as third paper above requested to accord Administrative Sanction for Conducting Topographic Survey of 23.813km of roads in Wayanad district for an amount of Rs.2.46 lakhs, meeting the expenses from CMDRF in line with the decision taken in meeting referred as second paper above.

Planning and Economic Affairs (RKI) department has offered concurrence for according Administrative Sanction for the work by meeting the expense from the funds already allotted to PMU-LSGD as per Government Order read as fourth paper above.
