## **ORDER**

As per references cited as 3 <sup>rd</sup> above, in-principle approval was accorded for the reconstruction of 614.6 Km of flood damaged LSGD roads with an estimated requirement of funds to the tune of ₹488 crore from the RKI. As per reference 5<sup>th</sup> above, Administrative Sanction was issued to 25 road works with a length of 39.893 Km at an estimated cost of ₹53.136 crore, including Thadikkakadavu-Vayalolam road in Karimalur GP, Ernakulam District at an estimated cost of ₹1.38 crore.

2. As per reference 7<sup>th</sup> above, the Project Director, PMU-RKI-LSGD submitted an estimate of ₹1.60 crore for the reconstruction of Chemikkad-Madrassappadi stretch of road, which is the continuation of the Thadikkakadavu-Vayalolam road stretch mentioned above. Thadikkadavu-Vayalolam-Chembikkad-Madrsappady road is a major link road with total length of 1.9 km starting from Thadikkadavu junction and ending at Veliyathunadu Road at Madrasappady Bus stop Junction. Reconstruction of the Chembikkad-Madrasappady stretch along with the existing stretch (Thadikkadavu - Vayalolam) was proposed, stressing the importance of the work in reducing the traveling distance to reach the Veliyathunadu road (by 4kms) and public utilities in the locality such as Agriculture office, Veterinary Hospital, Anganwadi etc. Earlier as per reference  $6^{\text{th}}$  above, PMU-LSGD had reported an approximate amount of ₹40 crore as savings under the works sanctioned as per reference  $4^{\text{th}}$  above.

**3.** The RKI-Implementation Committee (IC) meeting held on 20-10-2022 considered the proposal in detail, and, considering the necessity of ensuring junction connectivity to the ongoing project road, the Committee, as per reference  $8^{\text{th}}$  above, approved the project as an extension of ongoing project 'Thadikkakadavu- Vayalolam' road, (0.9 Km) at an estimated cost of ₹1.60 crore, subject to the condition that the proposed project cost shall be met from the overall savings of sanctioned works.

4. The Government, after having considered the matter in detail, are pleased to issue Administrative Sanction for the reconstruction of Chembikkad-Madrasappady road stretch as an extension of ongoing project 'Thadikkakadavu- Vayalolam' road, at an estimated cost of ₹1,60,00,000/- (Rupees One crore Sixty lakh only). The cost of the work shall be met from the savings available under G.O. referred 4<sup>th</sup> above. The expenditure in this regard shall be debited to the budget provision under H/A 5475-00- 115-94 Post flood Projects under Rebuild Kerala Initiative (P).

**5.** The Local Self Government Department shall implement the project through the Project Management Unit created in the Department for undertaking works connected with Rebuild Kerala Initiative. The Department shall ensure timely completion of the project. All mandatory clearances from relevant departments shall be obtained wherever applicable. All procurement as part of implementation of the work shall be done in a fair and transparent manner in accordance with the extant rules.
