### **ORDER**

As per the Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> paper above, a Project Management Unit (PMU) has been constituted in the Local Self Government

Department and entrusted tasks for the effective management of projects assigned to the department as part of Rebuild Kerala Initiative.

As per G.O.s read as 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup> and 11<sup>th</sup> papers above, Administrative Sanctions has been accorded for a total amount of ₹438.42 crore to various LSGD road projects under the RKI, of which the PMU-LSGD is the implementing agency.

As per G.O.s read as 4<sup>th</sup>, 6<sup>th</sup>, 10<sup>th</sup>, 12<sup>th</sup>, 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup>, 16<sup>th</sup> and 17<sup>th</sup> papers above, fund has been allotted and utilization certificates had been submitted by the LSGD-PMU, the financial year wise abstract of which is given below:

The Government have examined the matter in detail, and are pleased to sanction an amount to the tune of **₹15,00,00,000 (Rupees Fifteen crore only)** as the 10<sup>th</sup> installment to the Drawing and Disbursing Officer (with DDO Code No 0111996001) of the Project Management Unit, LSGD from the budget provision allocated under the head of account '5475-00-115-94-01-post flood projects under the Rebuild Kerala Initiative- (RKI)-World Bank aided-(01)-Roads of Local Self Government (RKI) (Plan), to meet the project cost and the administrative expenses of the Project Management Unit/Project Implementation Unit of LSGD as part of Rebuild Kerala Initiative projects in LSGD for the current financial year.


