ORDER

As per G.O. read 2nd above, 42 LSGD bridges/culverts were decided to be reconstructed under RKI through PMU-RKI-LSGD, which included Chottilappara bridge in Choondal GP, Thrissur Dist. (Sl. No.11 in the Annexure of the said G.O.). Later, as per G.O. read 3rd above, sanction was accorded for the soil investigation of 46 bridges including the above bridge.

- 2. The Project Director, PMU-RKI-LSGD, in his letter read 4 th above, submitted the DPR/estimate for the reconstruction of the Chottilappara bridge at an estimated cost of ₹2.90 crore, and requested Administrative Sanction for the same.
- **3.** The RKI-Implementation Committee, in its meeting held on 29-05-2023, the minutes of which is read as paper 5th above, considered the matter and approved the DPR/estimate, and directed the RKI to issue revised Administrative Sanction to the project. The financial requirements of the project is as follows;
