### ORDER

As per G.O read paper 3<sup>rd</sup> above, Administrative Sanction was issued to the reconstruction of 'Koipallymelepadi-Melethil padi Road', in Pathanamthitta District at an estimated cost of ₹ 1.44 crore.

2. The Project Director, PMU as per paper 4<sup>th</sup> above, forwarded a request from the Ayroor Gramapanchayath to change the name of the said road work. It is reported that though the coordinates of the work stretch (9° 21' 37.4"N, 76° 43' 24.9" E - 9°21'32.8"N, 76° 43' 26.2"E) matches with the records of the Ayroor Gramapanchayath and the Detailed Project Report (DPR) for the said work, the GP has reported that the name of this particular stretch is 'Vaikathethpadi - Koodathumannilpadi road', and hence, has requested modification of the name of the work accordingly.

3. In these circumstances, the Government, after having considered the matter in detail, do hereby modify the name of the work 'Koipallymelepadi-Melethil padi Road' to 'Vaikathethpadi - Koodathumannilpadi road'.

4. The G.Os read paper 2<sup>nd</sup> and 3<sup>rd</sup> above stand modified to this extent only.
