## <u>ORDER</u>

As per G.O. read  $3^{rd}$  paper above, Administrative Sanction was issued for the Renovation of Valavazhi Road in Angamaly Municipality in Ernakulam district at an estimated cost of ₹87 lakh.

**2.** As per letter read 4 <sup>th</sup> above, the Project Director, PMU reported that the contract for the work, which was originally executed with Shri. Navas P.S., was terminated at the risk and cost of the contractor on 20-02-2023 due to non-performance. The work was re-tendered on 19-06-2023. The details of the estimate is shown in the below table;

**3.** As per the above estimate details, an additional amount of ₹8,96,403/- is required over and above the existing Administrative Sanction amount (₹87,00,000/-). The Project Director reported that the additional amount shall be recovered from the original contractor, since the initial contract was terminated at risk and cost of the contractor. In this circumstance, the Project Director requested sanction for the revised estimated cost of the project.

4. The Government, after having considered the matter in detail, are pleased to accord sanction to the Renovation of Valavazhi Road in Angamaly Municipality in Ernakulam district at a revised estimated cost of ₹95,96,403/-(Rupees Ninety-five lakh Ninety-six thousand Four hundred and Three only). There shall be no additional commitment to the Rebuild Kerala Initiative in this regard. The additional amount required shall be recovered from the original contractor following extant rules. The G.O. read  $3^{rd}$  above, and the Annexure thereof, stand modified to this extent.
