<u>ORDER</u>

As per G.O. read paper 4th above, Administrative Sanction was issued to the reconstruction of Valiyapalli Kayalpuram School road in Alappuzha District at an amount of ₹4,30,00,000/- crore.

2. The Project Director, PMU, as per paper read 5th above, reported that the amount quoted for the work exceeds by an amount ₹53,37,158/above the approved estimate and requested to approve the same. He further reported that the excess amount quoted for the work is within the acceptable limits as stipulated by the G.O. cited 2^{nd} above and that the Tender Committee has recommended the L1 for the work, subject to approval from the Government.

3 . The details of the cost estimate with respect to the	e work is summarised below;

5. The Government, after having considered the matter in detail, are pleased to accord sanction the tender excess as detailed above. The Administrative Sanction issued for the work stands revised to an estimated cost of $\mathbb{Z}4,83,37,158/$ - (Rupees Four Crore Eighty-three lakh Thirty-seven Thousand One Hundred and Fifty-eight only). The expenditure in this regard shall be debited to the budget provision under H/A 5475-00-115-94-Post flood Projects under Rebuild Kerala Initiative (P).
