As per G.O. read as 9 <sup>th</sup> to 11 <sup>th</sup> papers above, a total amount to the tune of  $\mathbb{R}80,00,00,000$  ( $\mathbb{R}15,00,00,000/-+\mathbb{R}25,00,00,000/-+\mathbb{R}40,00,00,000/-$ ) has been sanctioned as the 10<sup>th</sup>, 11<sup>th</sup> and 12<sup>th</sup> installments respectively in the current F.Y., out of which an amount to the tune of  $\mathbb{R}79,44,86,373$  has been reported to be utilized until 04/01/2024.

5. As per letter read as  $12^{\text{th}}$  paper above, the Project Director, Project Management Unit of LSGD has requested to allocate an amount of ₹25,00,00,000/- to meet the project cost and administrative expenses of the
