<u>ORDER</u>

As per the Government Orders read as 1st and 2^{n d} paper above, a Project Management Unit (PMU) has been constituted in the Local Self Government Department and entrusted tasks for the effective management of projects assigned to the department as part of Rebuild Kerala Initiative. As per G.O.s read as 3rd to 9th papers above, Administrative Sanctions has been accorded for a total amount of ₹360 crore (approx.) to various LSGD road projects under the RKI, of which the PMU-LSGD is the implementing agency.
