ORDER

As per the Government Orders read as 1st and 2nd paper above, a Project Management Unit (PMU) has been constituted in the Local Self Government Department and entrusted tasks for the effective management of projects assigned to the department as part of Rebuild Kerala Initiative. As per G.O.s read as 3rd to 9th papers above, Administrative Sanctions has been accorded for a total amount of ₹360 crore (approx.) to various LSGD road projects under the RKI, of which the PMU-LSGD is the implementing agency. An amount to the tune of ₹191,63,62,187/- has already been utilized for the project till the F.Y. 2023-24.

2. As per the Government Order read as 10th paper above, an amount to the tune of ₹25,00,00,000/- has been allocated to the DDO of the Project Management Unit, LSGD, as 17th installment in the current F.Y.
3. As per letter read as 11th paper above, the Project Director, Project Management Unit of LSGD has requested to allocate an amount of ₹30 crore to meet the project cost and administrative expenses of the Project Management Unit/Project Implementation Unit- Rebuild Kerala Initiative- LSGD, in continuation of the already allocated fund.
4. The Government have examined the matter in detail, and are pleased to sanction an amount to the tune of **₹20,00,00,000/- (Rupees Twenty crore only)** as the 18th installment of funds to the DDO (with Code No.0111996001) of the Project Management Unit, LSGD, from the budget provision allocated under the head of account '5475-00-115-94- 01- *post flood projects under the Rebuild Kerala Initiative- (RKI)-World Bank aided- (01)- Roads of Local Self Government (RKI) (Plan)*, to meet the project cost and administrative expenses of the RKI funded LSGD road projects implemented through PMU-LSGD during the current quarter of the financial year 2024-25.
5. The Department shall furnish periodic status report of the implementation of the project, and the Utilization Certificate for the fund allotted, in a timely manner.
