ORDER

Administrative Sanction was issued for the roads, viz (i) Rehabilitation of Paduvathil police station road in Kadungallur GP in Ernakulam District and (ii) Upgradation of Moorthitta Mukkatheri Valayil Chakkittapalam Vallakali road in Alappuzha District, as per G.O. read paper 4th and 5th above, respectively. The road works were ordered to be implemented through the

Project Management Unit (PMU) formed in the LSGD under the RKI.

- 2. The contract with respect to Rehabilitation of Paduvathil police station road in Kadungallur GP in Ernakulam District was terminated at the risk and cost of contractor due to non performance. The work was retendered. The Project Director, PMU, as per his letter read as 6th paper above, informed that the least quoted amount was above the estimate PAC. The quoted rate is acceptable as per the provisions of the G.O. read as 2nd paper above. The Project Director further informed that the additional amount required would be recovered from the original contractor, the contract with whom has been terminated, and hence requested revised sanction for the work at an amount of ₹ 86,51,791/-
- **3.** The Project Director, PMU, as per his letter read as 7 th above, had reported that the work titled Moorthitta Mukkatheri Valayil Chakkittapalam Vallakali road in Alappuzha District was quoted above the estimate PAC. The quoted rate is found to be acceptable as per the G.O. read as 2nd above. The Project Director hence requested revised sanction for the work at an amount of ₹17,27,88,988/-.

- **5.**The expenditure in this regard shall be debited to the budget provision under H/A 5475-00-115-94-Post flood Projects under Rebuild Kerala Initiative (P).
