## **ORDER**

Estimates with respect to the road works taken up under RKI viz (i) Pallikudi city Mangathu palam road and (ii) Adivaram - Ottalanagalpady city road were revised to ₹2.62 crore and ₹3.12 crore respectively as per G.O. read 7<sup>th</sup> above.

2. The Project Director, as per letters read paper 5 <sup>th</sup> and 8 <sup>th</sup> above, submitted revised estimate with respect to Pallikudi city Mangathu palam road (₹4.84 crore) and additional work with respect to Adivaram -

Ottalanagalpady city road (₹43.5 lakhs) respectively. The revision in costs/additional works are attributed to the necessity of additional excavation, protection works as per the site conditions. The revised cost details of the above two road works are summarised below;

**3.** The RKI Implementation committee in its meeting held on 03.07.2024, approved the revised estimate of Pallikudi city Mangathu palam road, subject to the condition that the additional items of works over and above the already executed items with respect to the said road will be considered as a separate work and tendered accordingly. The Committee also approved additional works worth ₹43.5 lakhs with respect to Adivaram -

Ottalanagalpady city road.

4. In the above circumstances, the Government, after having considered the matter in detail, are pleased to issue sanction to the revised estimate of Pallikkudi city Mangathu palam road at an amount of ₹4,84,00,000/-(Rupees Four crore and Eighty-four lakh only), subject to the condition that the additional items of works over and above the already executed items with respect to the work will be considered as a separate work and shall be tendered accordingly. Sanction is also accorded for the additional works with respect to Adivaram - Ottalanagalpady city road in Idukki District at an amount of ₹43,50,000/- (Rupees Forty-three lakh Fifty-thousand Only). The expenditure in this regard shall be debited to the budget provision under H/A 5475-00-115-94-Post flood Projects under Rebuild Kerala Initiative (P).
