ORDER

As per the Government Orders read as 1 st and 2 nd paper above, a Project Management Unit (PMU) has been constituted in the Local Self Government Department and entrusted tasks for the effective management of projects assigned to the department as part of Rebuild Kerala Initiative. As per G.O.s read as 3 nd to 19 nd papers above, Administrative Sanction has been accorded for a total amount of ₹460.169 crore to various LSGD road projects under the RKI, of which the PMU-LSGD is the implementing agency. An amount to the tune of ₹191,63,62,187/- has already been utilized for the project till the F.Y. 2023-24. In addition to this, as per the G.O.s read as 20 th to 22 nd papers above, an amount to the tune of ₹65,00,00,000/- has been allocated to the DDO of the Project Management Unit, LSGD, in the current F.Y.
