ORDER

As per Government Order read as 2nd above, Delhi Schedule of Rates 2021 (DSoR 2021) had been implemented for all Public Works in the State with effect from 1/4/2025. Further, as per Government Order read as 3rd above, directions were given for the execution of public works in DSoR 2021.

As per the Government Order read as 1st above, Departmental Tender Committees are delegated to accept bids where the maximum admissible tender excess are limited either to the quoted rate of the lowest bidder or local market rates or current DSoR+10% tolerance limit whichever is less.

Government observed that it would be a great inconvenience for the Departments to accept the bid prepared in DSoR 2018 and being evaluated after the applicability of DSoR 2021.

Government have examined the matter in detail and are pleased to issue orders permitting Departmental Tender Committees for acceptance of bids where estimate is prepared in Schedule of Rates prior to the introduction of DSoR 2021, but tender procedures are finalised after the

date of applicability of DSoR 2021 ie, 01/04/2025, if it is least of the quoted rate of the lowest bidder(L1) or Local Market Rate(LMR) or DSoR 2021 plus 10% tolerance limit, whichever is less.


